

**A. All Emergencies – Dial 911**

1. All *life threatening* situations
2. All suspected crimes in progress (Examples include, but not limited to)
  - a. Robbery
  - b. Shots Fired/Shootings

**B. Non Emergencies – Dial 414-933-4444 Option 9**

1. When an officer is needed at the scene but the situation is not life threatening.
  - a. Loud Music
  - b. Neighbor trouble (Non-violent)

**C. Online Self Reporting (Milwaukeepdwi.policetocitizen.com)**

1. Self-report non-emergency incidents.
  - a. Theft or vandalism less than \$2,500
  - b. Ordinance violations/misdemeanors with no suspect/investigate leads.

**D. District Notifications – Dial 414-935-7252 (5<sup>th</sup> District)**

1. Non-emergencies when a squad is not needed.
  - a. FAX number 414-935-7115 (Hot spot forms or drug complaint forms)

The Milwaukee Police Department has partnered with the City of Milwaukee's Office of Electronic Government in an effort to publicize police news and information to the citizens of Milwaukee.

Department members can now post press releases, crime trend bulletins, block watch information, and auxiliary news on this web site.

In order to access E-NOTIFY, complete the following steps:

- 1) Go to [www.milwaukee.gov](http://www.milwaukee.gov)
- 2) Click on City of Milwaukee
- 3) Under the RESIDENTS tab, Click on E, then E-Notify Email Notifications
- 4) To create a NEW account, click on **Register, Sign-in, or Reset Password**  
If you already have an account, log in. To create a new account, click on register
- 5) Go to E-Notify and select what newsletters you would like to receive.
